Confluence is a team collaboration software, installed in the University of Klagenfurt servers. ### 4 Roles and responsibilities

The NEON Confluence space is accessible to a selected number of people. Only the administrators of the space can assign and modify user roles. The following sub-sections define the role of each user category. In addition, Confluence keeps a history of all changes made to pages and other content, therefore, it is easy to see who has changed which section or content, and reverse any changes if needed.

#### 4.1 Administrators

Each subspace in Confluence has its own set of permissions, which can be granted and revoked by a space administrator. The user that creates a subspace, is automatically the administrator of that space. At the moment, the Confluence administrator is Andrea Tonello.

#### 4.2 Users

The users can view, add, edit, and delete content within a particular space.

#### 4.3 Viewers

The viewers can only see the content in the space.
